Interested agencies shall submit their applications within seven (07) days from the date of publication of this notice in the newspapers, either by hand in a sealed cover or by registered/speed post, along with all the required documents, including a CDR of ₹10,000/- (Rupees Ten Thousand only) pledged in favour of the Principal, Government Degree College Tral.

General Terms and Conditions

1. The firms (Book Suppliers/Distributors/Publishers/Vendors) are expected to examine and abide by all the terms and conditions of the Institution as specified in this document. Failure to furnish all the required information or submission of an offer that is not substantially responsive to these terms and conditions may result in rejection of the firm's application for empanelment.
2. The documents should be complete in all respects and must reach the office of the undersigned within the prescribed time as mentioned in the Expression of Interest (EOI) notice.
3. All pages of the Empanelment/Expression of Interest documents shall be duly signed and stamped by the firm and submitted along with the application form and self-attested copies of the required documentary proofs.
4. The period of empanelment/expression of interest shall be for the financial years 2026 to 2027.
5. The firm shall undertake the supply of all categories of books and clearly indicate the discount rates separately for normal and hardbound editions.
6. The prices quoted shall be in accordance with the latest publishers' printed catalogues. Books with tampered, erased, mutilated, or altered prices shall not be accepted. All books supplied must be genuine and free from piracy in accordance with the provisions of the Copyright Act.
7. The decision of the Principal, Government Degree College Tral, in all matters relating to the procurement of books shall be final and binding on all concerned.
8. For foreign publications, the applicable Government of India/Good Office Committee exchange rates shall be followed.
9. A minimum discount of 10% shall be offered on all books.
10. The firm shall quote separate discount rates for Text Books, Reference Books, and Other Books.
11. If, at any stage, it is found that the vendor has furnished false or misleading information, the firm shall be debarred from empanelment and blacklisted.
12. Vendors/Suppliers/Publishers/Distributors shall acknowledge receipt of the supply order/letter within seven (07) days of its issuance.
13. The supplier shall complete the supply of books within 21 days from the date of issuance of the supply order/letter.
14. If the ordered books are not supplied within the stipulated delivery period, the supply order/letter shall be deemed to have been cancelled automatically without any further notice.
15. All supplies shall be made on an F.O.R. Government Degree College Tral premises.
16. The Principal, Government Degree College Tral, reserves the right to accept or reject any application for empanelment or to cancel the empanelment process without assigning any reason thereof.
